

Supplementary statement to the Public Health Dorset Pharmaceutical Needs Assessment 2022 – 2025

Public Health Dorset produced the 2022 PNA for Bournemouth, Christchurch and Poole (BCP) Health and Wellbeing Board and Dorset Health and Wellbeing Board. This was published in October 2022.

This supplementary statement replaces the previous supplementary statement that was published in July 2023.

Date supplementary statement issued: May 2024

1. Closing of a pharmacy

The following pharmacies have closed in the **BCP council Health and Wellbeing Board** area:

- Lloyds in Sainsburys at 1 Lyndhurst Road, Christchurch (FHL51). This was a 100-hour pharmacy. It closed on 13 March 2023.
- Lloyds in Sainsburys at Castlepoint, Bournemouth (FDL19). This was a 40-hour pharmacy. It closed on 18 April 2023.
- Lloyds in Sainsburys at Talbot Heath, Poole (FRH25). This was a 40-hour pharmacy. It closed on 18 April 2023.
- Boots Pharmacy at 960 Wimborne Road, Moordown, Bournemouth (FWP45). This was a 40-hour pharmacy. It closed on 26 January 2024.
- Boots Pharmacy at Beaufort Road Surgery, Bournemouth (FHQ83). This was a 40-hour pharmacy. It closed on 15 March 2024.
- Boots Pharmacy at 364 Ashley Road, Parkstone, Poole (FCN32). This was a 40-hour pharmacy. It closed on 27 April 2024.

The following pharmacies have closed in the **Dorset council Health and Wellbeing Board** area:

- Verwood Pharmacy, Lake Road Surgery – ceased provision at short notice in July 2023.
- Boots Pharmacy at 54-56 Fortuneswell, Portland (FMT96). This was a 40-hour pharmacy. It closed on 17 February 2024.

2. Consolidation of two pharmacies

In the **BCP council Health and Wellbeing Health and Wellbeing Board** area, the two Rowlands Pharmacies at 14 Parkstone Road, Poole and 117a Longfleet Road in Poole have consolidated onto the 14 Parkstone Road site (FGC36). The 117a Longfleet Road site (FXN20) closed on 1 February 2024.

3. No significant change relocation

The following pharmacy in the **Dorset council Health and Wellbeing Board** area has changed location:

- The pharmacy at 23 Station Road, Verwood has moved approx. 0.1 miles to Bank Court, Verwood. The relocation took place on 9 December 2023.

4. Opening of a pharmacy

In the **Dorset council Health and Wellbeing Board area** a new distance selling pharmacy opened at Unit 52F Enterprise Park, Piddlehinton with effect from. Trading as Automeds (FRD44), the start date for provision of pharmaceutical services was 26 July 2023.

5. Change of ownership

The following pharmacies in the **BCP council Health and Wellbeing Board area** have changed ownership:

- The pharmacy at Parkstone Health Centre. Shore Medicines Ltd. took over ownership from Lloyds Pharmacy on 3rd July 2023. The new trading name is Shore Pharmacy (FLC78)
- The pharmacy at 10 Station Road, Parkstone, Poole. Click Solutions Ltd. took over ownership from Lloyds Pharmacy on 7th July 2023. The new trading name is Parkstone Pharmacy (FRW74)
- The pharmacy at Rosemary Health Centre, Poole. LP SD Fifty Limited took over the ownership from Lloyds on 2 September 2023. The new trading name is Lloydspharmacy (FJH06).
- The pharmacy at 192c Lower Blandford Road, Broadstone. Sibanda Pharma Ltd took over the ownership from Lloyds on 29 September 2023. The new trading name is Broadstone Village Pharmacy (FMA26).
- The pharmacy at 446 Kinson Road, Bournemouth. LP SD Ninety Seven Limited took over the ownership from Lloyds on 25 October 2023. The new trading name is Lloydspharmacy (FE870).
- The pharmacy at 52 Anchor Road, Bournemouth. Bear Cross Pharma Ltd. took over ownership from Day Lewis PLC on 16 February 2024. The new trading name is Bear Cross Pharmacy (FJ896).

Since February 2024, there are two other pharmacies where we have been notified that an application for change of ownership has been granted but this has not yet been completed.

The following pharmacies in the **Dorset council Health and Wellbeing Board area** have changed ownership:

- The pharmacy at 1 Frederick Treves House, St. Johns Way, Poundbury, Dorchester. Aunpharma took over the ownership from Rowlands pharmacy on 1 March 2023. The new trading name is Poundbury Pharmacy (FN115).
- The pharmacy at 26 Abbotsbury Road, Weymouth. Weymouth Pharma took over the ownership from Boots UK Ltd. on 24 April 2023. The new trading name is Weymouth Pharmacy (FPN51).
- The pharmacy at 23 Station Road, Verwood. Pharmland Ltd took over ownership from Lloyds Pharmacy on 30 May 2023. The new trading name is Verwood Pharmacy (FXG05).
- The pharmacy at High Street, Stalbridge. MB Stalbridge Ltd took over ownership from Stalbridge Pharmacy on 3 August 2023. The new trading name is Stalbridge Pharmacy (FAW80).
- The pharmacy at Abbey View Medical Centre, Shaftesbury. LP SD Nine Limited took over ownership from Lloyds on 4 August 2023. The new trading name is Jhoots Pharmacy. (FG146)
- The pharmacy at 22 Gloucester Street, Weymouth. LP SD Fifty Limited took over the ownership from Lloyds on 2 September 2023. The new trading name is Lloydspharmacy (FM216).
- The pharmacy at 45 Broad Street, Lyme Regis. SNJ Health Ltd. took over the ownership from Boots UK Ltd. on 26 February 2024. The new trading name is Jhoots Pharmacy (FHG74).
- The pharmacy at Lyme Regis Community Care. LP SD Eight Ltd. took over the ownership from Lloyds. The new trading name is Jhoots Pharmacy.
- The pharmacy at at Bridport Medical Centre. LP SD Fifty Ltd. took over the ownership from Lloyds. The new trading name is Jhoots Pharmacy.

Since June 2023, there are four other pharmacies where we have been notified that an application for change of ownership has been granted but this has not yet been completed.

6. Reduction in core hours

Due to a change in regulations, 100-hour pharmacies can now apply to reduce their opening hours to a minimum of 72 hours.

The following pharmacies in the **BCP council Health and Wellbeing Board area** have reduced their core hours:

- Poole Bay Pharmacy, Westbourne Medical Centre, Bournemouth (FM668). Core hours reduced to 82 hours from 3 July 2023.
- Asda Pharmacy, West Quay Road, Poole (FM329). Core hours reduced to 72 hours from 10 July 2023.
- Castle Lane Pharmacy, 482 Castle Lane West, Bournemouth (FA612). Core hours reduced to 77 hours from 6 August 2023.
- Canford Heath Pharmacy, 9 Mitchell Road, Poole (FRK84). Core hours reduced to 76 hours from 8 August 2023.
- Wallisdown Pharmacy, 337 Wallisdown Road, Poole (FVA67). Core hours reduced to 82 hours from 14 August 2023.
- Tesco Instore Pharmacy, Poole Road, Poole (FHE41). Core hours reduced to 78 hours from 29 August 2023.
- Tesco Instore Pharmacy, Yarrow Road, Poole (FCG62). Core hours reduced to 78 hours from 29 August 2023.

As a result of these changes there are no pharmacies in the BCP Health and Wellbeing Board area that remain open for 100-hours a week.

The following pharmacies in the **Dorset council Health and Wellbeing Board area** have reduced their core hours:

- Asda Pharmacy, Newstead Road, Weymouth (FHC86). Core hours reduced to 72 hours from 10 July 2023.
- Ferndown Pharmacy, 487 Ringwood Road, Ferndown (FFE58). Core hours reduced to 72 hours from 12 July 2023.
- Tesco Instore Pharmacy, Weymouth Avenue, Dorchester (FMG47). Core hours reduced to 78 hours from 29 August 2023.
- Boots Pharmacy, Unit 7, The Peel Centre, Yeovil (FV817). Core hours reduced to 72 hours from 11 September 2023.

As a result of these changes there are no pharmacies in the Dorset Health and Wellbeing Board area that remain open for 100-hours a week.
